## Programs in Demand, But Out of Reach for Many

### Demand for programs is enormous.

In Rhode Island, the demand for afterschool programs is incredibly high. But just a fraction of Rhode Island families who want afterschool programs have them.


Parents value the benefits afterschool programs provide for young people—keeping them safe, helping them build life skills, and getting them excited about learning—and say afterschool programs help parents keep their jobs and provide peace of mind.

### Behind the demand: Parents see afterschool programs addressing their top-of-mind concerns.

An overwhelming majority of parents agree that afterschool programs benefit kids and parents.

#### BENEFITS TO KIDS

- 80%** Keeps them safe
- 86%** Builds social skills and responsible decision making
- 86%** Boosts teamwork, critical thinking, and leadership skills
- 79%** Supports well-being
- 79%** Excites them about learning and improves school attendance
- 86%** Encourages fun and learning, decreasing screen time



#### BENEFITS TO PARENTS:<sup>\*</sup>

- 78%** Helps them keep their job or work more hours
- 93%** Leads to less stress because they know their child is safe
- 91%** Boosts productivity at work
- 86%** Positively impacts overall well-being

### Rhode Island parents give their children's afterschool programs high marks.

With a quality score of 4.31 out of 5, 89% of parents rate their child's afterschool program as "excellent" or "very good."

## With many Rhode Island families facing barriers to afterschool participation, there is strong support for public funding.

### PROGRAM AFFORDABILITY, ACCESSIBILITY, AND AVAILABILITY LIMIT PARTICIPATION.

Rhode Island parents cite barriers to enrolling their children in afterschool programs:

### RHODE ISLAND PARENTS SUPPORT ACCESS AND FUNDING.

More than 5 in 6 Rhode Island parents (86%) agree that all young people deserve access to quality afterschool and summer programs and about 9 in 10 (89%) are in favor of public funding for afterschool opportunities. Across political affiliations, support for public funding is high.

#### About the Survey

America After 3PM is a national online survey of parents or guardians of school-aged children, with supplemental interviews conducted by telephone. Data were collected by Edge Research on behalf of the Afterschool Alliance. In Rhode Island, 216 households and 365 children were screened for this study. Child-level statewide projections are based on total school enrollment numbers for the 2021-2022 school year from the U.S. Department of Education, National Center for Education Statistics.
